Resolved: That Cllr Gundry will write to the case officer, to be forwarded by the Deputy Town Clerk, based on the original comments, to include;

- The provision of a footpath to the School and fencing on the School boundary is welcomed.
- There is no indication of the provision a high fence / screening on the western boundary of the Flying Monk Football Ground, which is owned by the Town Council, to provide visual and access protection from the west. This was a requirement in the comments made by MTC in January 2019.
- No indication of lighting on the footpath from the housing area to Park Road. We consider this is necessary for safety and security reasons.
