The external auditor report given in Section 3 of the Annual Governance & Accountability Return requires amendments as follows:

Except for the matters reported below, on the basis of our review of Sections 1 and 2 of the Annual Governance and Accountability Return (AGAR), in our opinion the information in Sections 1 and 2 of the AGAR is in accordance with Proper Practices and no other matters have come to our attention giving cause for concern that relevant legislation and regulatory requirements have not been met.


Section 1, Assertion 5 has been incorrectly completed, the response should read 'No' as adequate risk management procedures are not in place. This is consistent with the Internal Auditor's response to Internal Control Objective C which although no conclusion was given, the Internal Auditor did confirm that the intended response is 'No'. We note that this matter was also raised by the internal auditor in the prior year and therefore Section 1, Assertion 7 has also been incorrectly answered.
